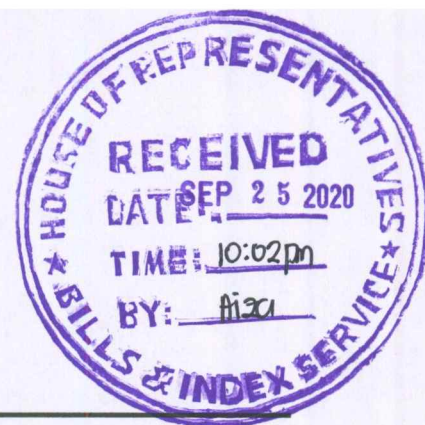

**AN ACT**  
**CHANGING THE NAME OF SAN MANUEL HIGH SCHOOL IN BARANGAY**  
**SAN MANUEL, CITY OF SAN JOSE DEL MONTE, PROVINCE OF BULACAN,**  
**TO SAN MANUEL NATIONAL HIGH SCHOOL**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. The name of San Manuel High School in Barangay San Manuel, City  
2 of San Jose Del Monte, Province of Bulacan, is hereby changed to San Manuel National  
3 High School.

5           SEC. 2. The main campus of the San Manuel National High School shall continue  
6 to remain in its present location in Barangay San Manuel, City of San Jose Del Monte,  
7 Province of Bulacan.

9           SEC. 3. This Act shall take effect fifteen (15) days after its publication in the  
10 *Official Gazette* or in a newspaper of general circulation.
