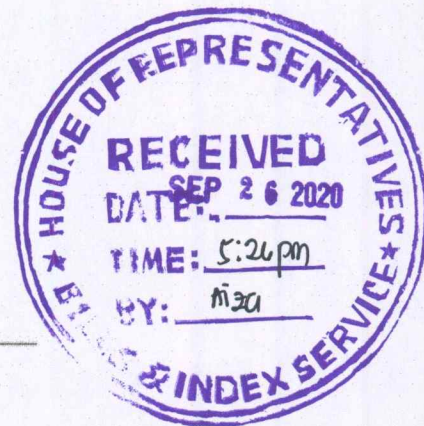

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

2           **SECTION 1.** July 5 of every year is hereby declared a special non-working holiday in  
3 the Municipality of Bambang, Province of Nueva Vizcaya to be known as “*Bambang Day*”, in  
4 commemoration of its foundation anniversary.

5           **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*  
6 *Gazette* or in a newspaper of general circulation.
