AN ACT
RENAMING THE QUEZON CITY GENERAL HOSPITAL TO QUEZON CITY GENERAL HOSPITAL AND MEDICAL CENTER, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 537, AS AMENDED

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The title of Article XIV – A of Republic Act No. 537, as amended by
2 Republic Act No. 6548, is hereby amended as follows:

4 "Article XIV – A – Quezon City General Hospital **AND MEDICAL CENTER**"

6 **SEC. 2.** All other provisions of Republic Act No. 6548 which have reference to the
7 "Quezon City General Hospital" shall be correspondingly amended to reflect the change in
8 name, and any reference to "*hospita*" shall refer to Quezon City General Hospital and Medical
9 Center.

11 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the *Official*
12 *Gazette* or in a newspaper of general circulation.
