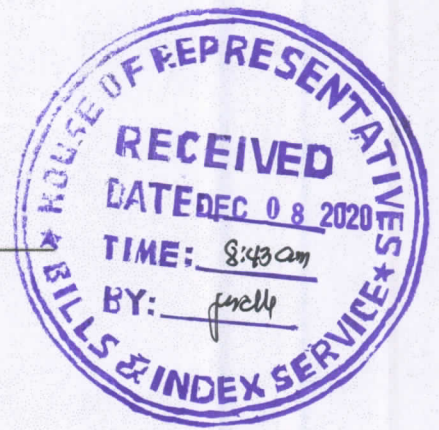

AN ACT
DECLARING DECEMBER 28 OF EVERY YEAR A SPECIAL NON-WORKING
HOLIDAY IN THE MUNICIPALITY OF TUDELA, PROVINCE OF MISAMIS
OCCIDENTAL, TO BE KNOWN AS “TUDELA DAY” IN COMMEMORATION OF ITS
FOUNDATION ANNIVERSARY

*Be it enacted by the Senate and the House of Representatives
of the Philippines in Congress assembled:*

1 **SECTION 1.** December 28 of every year is hereby declared a special non-working
2 holiday in the Municipality of Tudela, Province of Misamis Occidental, to be known as “*Tudela*
3 *Day*” in commemoration of its Foundation Anniversary.

4 **SEC. 2.** This Act shall take effect fifteen (15) days after its publication in the *Official*
5 *Gazette* or in a newspaper of general circulation.
