AN ACT
**NAMING THE FIRST CEBU-MACTAN BRIDGE TRAVERSING THE MACTAN CHANNEL
LOCATED AT A.C. CORTES AVENUE IN BARANGAY LOOC, MANDAUE CITY UP TO
THE MANDAUE-MACTAN ROAD IN BARANGAY PAJO, LAPU LAPU CITY, BOTH IN THE
PROVINCE OF CEBU, AS SERGING VELOSO OSMEÑA JR. BRIDGE**

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The First Cebu-Mactan Bridge traversing the Mactan Channel located at A.C. Cortes Avenue
2 in Barangay Looc, Mandaue City up to the Mandaue-Mactan Road in Barangay Pajo, Lapu Lapu City,
3 both in the Province of Cebu, comprising a total distance of 854 meters, is hereby named as Serging Veloso
4 Osmeña Jr. Bridge.

5 **SEC. 2.** The Department of Public Works and Highways shall issue the necessary rules, orders, and
6 circulars to implement the provisions of this Act within sixty (60) days from its effectivity.

7 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a
8 newspaper of general circulation.
