AN ACT
DECLARING THE CEBU SAFARI AND ADVENTURE PARK LOCATED IN
BARANGAY CORTE, MUNICIPALITY OF CARMEN, PROVINCE OF CEBU, A
TOURISM DESTINATION

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The Cebu Safari and Adventure Park located in Barangay Corte,
2 Municipality of Carmen, Province of Cebu, which offers diverse tourist attractions and host to a
3 variety of zoological and botanical species, is hereby declared a tourism destination.

4 **SEC. 2.** The Department of Tourism shall include in its tourism infrastructure program
5 and national tourism development program the implementation of this Act.

6 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the *Official*
7 *Gazette* or in a newspaper of general circulation.
