**AN ACT**

**CREATING TWO (2) ADDITIONAL BRANCHES OF THE REGIONAL TRIAL COURT IN THE SEVENTH JUDICIAL REGION TO BE STATIONED IN THE MUNICIPALITIES OF CANDIJAY AND VALENCIA, PROVINCE OF BOHOL, AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE SECTION 14(H) OF BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS 'THE JUDICIARY REORGANIZATION ACT OF 1980', AS AMENDED**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1       **SECTION 1.** Two (2) additional branches of the Regional Trial Court in the Seventh  
2 Judicial Region are hereby created and stationed in the Municipalities of Candijay and  
3 Valencia, Province of Bohol.

4  
5       The Supreme Court shall assign the respective branch numbers for the newly  
6 created branches of the Regional Trial Court.

7  
8       **SEC. 2.** The Chief Justice of the Supreme Court, in coordination with the Secretary  
9 of the Department of Justice, shall immediately include in the Court's program the  
10 operationalization of the additional branches of the Regional Trial Court in the  
11 municipalities of Candijay and Valencia, Province of Bohol. The funds necessary for the

1 operation of the courts herein created shall be appropriated and released only upon the  
2 actual organization of the courts and the appointment of its personnel.

3  
4 **SEC. 3.** Section 14 (h) of Batas Pambansa Blg. 129, otherwise known as "The  
5 Judiciary Reorganization Act of 1980", as amended, and all other laws, rules and  
6 regulations which are inconsistent with this Act are hereby amended, repealed or  
7 modified accordingly.

8  
9 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the *Official*  
10 *Gazette* or in a newspaper of general circulation.

#### **OBJECTIVE:**

- To ensure the speedy disposition of cases and to declog court dockets.

#### **KEY PROVISIONS:**

- Creates two (2) additional branches of the Regional Trial Court (RTC) in the Seventh Judicial Region to be stationed in the Municipalities of Candijay and Valencia, Province of Bohol.
- Mandates that the funds for the operation of the additional RTC shall be appropriated and released only upon the actual organization of the court and the appointment of its personnel.

#### **RELATED LAWS:**

- **Batas Pambansa Blg. 129**, otherwise known as "The Judiciary Reorganization Act of 1980"
