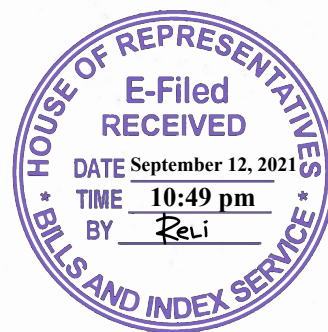

SEPARATING THE ARENA BLANCO NATIONAL HIGH SCHOOL – MAMPANG ANNEX IN BARANGAY MAMPANG, ZAMBOANGA CITY FROM THE ARENA BLANCO NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS MAMPANG NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Arena Blanco National High School – Mampang Annex in
2 Barangay Mampang, Zamboanga City is hereby separated from the Arena Blanco National
3 High School and converted into an independent national high school to be known as
4 Mampang National High School.

5
6 SEC. 2. All personnel, assets, liabilities and records of the Arena Blanco National
7 High School – Mampang Annex are hereby transferred to and absorbed by the Mampang
8 National High School.

9
10 SEC. 3. The Secretary of Education shall immediately include in the Department’s
11 program the operationalization of the Mampang National High School, the initial funding of
12 which shall be charged against the current year’s appropriation of the Arena Blanco National
13 High School – Mampang Annex. Thereafter, the amount necessary for the continued
14 operation of the school shall be included in the annual General Appropriations Act.

15
16 SEC. 4. Within sixty (60) days after the approval of this Act, the Secretary of
17 Education shall promulgate the rules and regulations implementing the provisions of this Act.

18
19 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the *Official*
20 *Gazette* or in a newspaper of general circulation.
